

Safeguarding & Child Protection Policy

All teachers and teaching assistants within the school have attended child protection training. It must be acknowledged that within our school some of our pupils will have experienced disturbing situations and as a result are placed on the child protection register. Recognising this, the school take every necessary precaution to ensure that individual concerns with regard to pupils will be addressed by staff at all times.

The school believes that should the level of disturbance of an individual pupil ever reach a stage when it interferes with the development of other pupils or impacts on the day to day running of the school then action will need to be taken. This may include contacting the principle care manager, calling an emergency planning meeting, contacting the social worker or local child protection team. With appropriate consent we may also refer the student to other outside agencies.

The Continuum Care and Education Group fully recognises its responsibilities for child protection. Our policy applies to all staff, governors and volunteers working in the school. The five main elements to our policy are to:

- **ensure we practice safe recruitment in checking the suitability of staff and volunteers to work with children**
- **raise awareness of child protection issues and equip children with the skills needed to keep them safe**
- **develop and implement procedures for identifying and reporting cases, or suspected cases, of abuse**
- **support pupils who have been abused in accordance with the agreed child protection plan**
- **establish a safe environment in which children can learn and develop.**

We recognise that, because of their day-to-day contact with children, school staff are well placed to observe the outward signs of abuse. The school will therefore:

- **establish and maintain an environment where children feel secure, are encouraged to talk, and are listened**
- **to ensure children know that there are adults in the school whom they can approach if they are worried**
- **include opportunities in the personal, social, health and economic (PSHE) curriculum for children to develop the skills they need to recognise and stay safe from abuse.**

We will follow the procedures set out by the Local Safeguarding Children Board (LSCB) and take account of guidance issued by the DfE to:

- **ensure we have a designated senior person for child protection who has received appropriate training and**
- **support for this role**
- **ensure we have a nominated governor responsible for child protection**

- ensure every member of staff (including temporary and supply staff and volunteers) and governing body
- knows the name of the designated senior person responsible for child protection and their role
- ensure all staff and volunteers understand their responsibilities in being alert to the signs of abuse and responsibility for referring any concerns to the designated senior person responsible for child protection
- ensure that parents have an understanding of the responsibility placed on the school and staff for child
- protection by setting out its obligations in the school prospectus notify social services if there is an unexplained absence of more than two days of a pupil who is on the child protection register
- develop effective links with relevant agencies and cooperate as required with their enquiries regarding
- child protection matters, including attendance at case conferences
- keep written records of concerns about children, even where there is no need to refer the matter immediately
- ensure all records are kept securely, separate from the main pupil file, and in locked locations
- develop and then follow procedures where an allegation is made against a member of staff or volunteer
- ensure safe recruitment practices are always followed.

We recognise that children who are abused or witness violence may find it difficult to develop a sense of self worth. They may feel helplessness, humiliation and some sense of blame. The school may be the only stable, secure and predictable element in the lives of children at risk. When at school their behaviour may be challenging and defiant or they may be withdrawn. The school will endeavour to support the pupil through:

- the content of the curriculum;
- the school ethos which promotes a positive, supportive and secure environment and gives pupils a sense of being valued;
- the school behaviour policy which is aimed at supporting vulnerable pupils in the school. The school will ensure that the pupil knows that some behaviour is unacceptable but they are valued and not to be blamed for any abuse which has occurred;
- liaison with other agencies that support the pupil such as social services, Child and Adult Mental Health
- Service (CAHMS), education welfare service and educational psychology service;
- ensuring that, where a pupil on the child protection register leaves, their information is transferred to the
- new school immediately and that the child's social worker is informed.

The school has positive links with the local Child Protection Team and when appropriate, concerns are discussed with an officer from that team. Anyone with concerns of this nature should immediately inform the Head of Education who may be contacted on 01706 644 471.
